### What are China Customs Declarations?

China customs declarations are mandatory forms you submit when entering or leaving China with certain goods or amounts of currency. These declarations help Chinese authorities monitor and control what crosses their borders in line with national regulations. The main document for customs declaration in China is the Customs Declaration Form.

### What if a customs declaration value is less than 5000?

are declared officially (category D) or by express (category C)?

If customs declare value is less than RMB 5,000 with reasonable quantity and weight; and excluding licensing controls, export tax refund or export verification.

### What documents do I need for customs declaration in China?

The main document for customs declaration in China is the Customs Declaration Form. You must complete this form in duplicate when entering China with items that require declaration. Keep the carbon copy as proof for your exit. Travelers also need:

### What is the difference between declared value and customs value?

is the selling or the replacement price of the shipment. The declared value is the same as customs value in terms of the value of the shipment, but declared value is used to determine the maximum liability in connection with the shipment of the item(s). The declared value for carriage cannot exceed the customs value. 8. Should my shipment be declared?

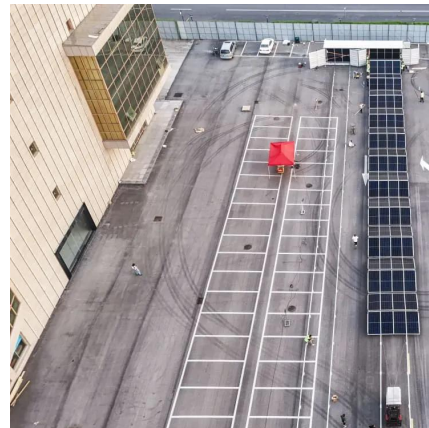

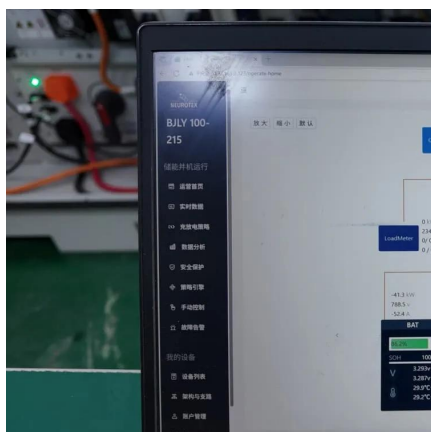
